VDVKs are being setup for processing / value addition to non – timber Minor Forest Produces being collected by the Members of Tribal SHGs. Objective for setting up such centers is to create sustainable livelihood for the ST SHGs through collection, minor processing, value addition, market linkage etc. of MFPs. West Bengal Tribal Development Co-operative Corporation Ltd. now invites sealed Tenders from bonafide bidders (competent organizations / Institutes / Consultancy Firms / NGOs / Society/ Universities and Research Institutions) to undertake the assignment for operation of following 22 (twenty two) VDVKs mapped with the **specified MFPs(minor forest produce)** along with other viable economic activities.

Information to Bidders (ITB): -

1. WBTDCCLtd. may provide finance up to Rs. 14.00 lakh per VDKV for entire scope of work which include cost of training, equipments and machinery, procurement of raw materials, marketing support etc. for 1st two years of operation. The contract would be to make it operational and profitable by these two years. Bidders are to quote rate in consideration of the above fact.
2. Bidders are to submit Bids in two separate sealed cover **1. Technical Bid** – Cover letter, Detailed write up on scope of work and Business Plan duly filled in **Annexure-1** **2. Financial Bid** – Format prescribed in Annexure-II
3. Both the sealed covers should be addressed to “**WBTDCCLtd, Sidhu KanuBhawan, KB-18, Sector-III, Kolkata – 700 106**” and to be submitted by hand or post by 3:00 PM of **13.10.22**. Proposals submitted beyond stipulated Date and Time will not be considered.
4. A detailed description must be provided in consonance with the scope of work.
5. The Application must be submitted in the English language and in the format prescribed by WBTDCCLtd. All required information must be provided, responding clearly and concisely to all the points set out. Any application which does not fully and comprehensively address the points regarding scope of work may be rejected.

7. Two stage evaluations shall be followed. In the first stage, Technical Bids shall be evaluated on the basis of demonstrated capacity, technical knowhow and business plan. Financial bids of technically qualified bidders only will be opened and financial evaluation would be on the basis of lowest rate quoted. In case of a tie bid, the Corporation may opt for further bidding among the tie bidders. The corporation may also agree on a single lowest rate and distribute the work among all the bidders who agrees on the single lowest bid. Decision of the corporation shall be final.
8. Applications shall not be modified or withdrawn after the deadline.
